Dear Administrator McCarthy,

Thank you for your leadership in addressing environmental issues to ensure that our children have a healthy and abundant future. As African American leaders in communities the hardest hit by climate change, we are writing to encourage your continued action on addressing methane pollution.

We are already seeing the impacts of climate change, particularly in marginalized communities. Climate change poses serious threats to the African American community, endangering the health and livelihood of millions of African American families in the United States. From heat-related mortality to increased asthma attacks to lost job opportunities, climate change disproportionately impacts African American communities, particularly when it comes to public health.

Methane is a highly potent heat-trapping pollutant that warms the climate 86 times more than carbon dioxide during the first twenty years after its release. The most significant source of methane emissions are oil and gas operations, which also emit other dangerous pollutants that harm our communities' health, including smog-forming volatile organic compounds (VOCs) and cancer-causing pollutants like benzene. Over one million African Americans live within a half a mile of oil and gas infrastructure. Strong methane pollution standards will deliver significant public health benefits by cutting emissions of these toxic air pollutants.

We applaud the EPA for beginning the formal process to require the oil and gas industry to provide information to assist in the development of comprehensive regulations to reduce methane emissions. The Information Collection Request (ICR) rule is an important first step in regulating existing sources of methane pollution.

Every child has the right to a pollution-free environment. We have a moral obligation to protect God's gift of air for our children and grandchildren. We applaud your leadership and urge you to continue to protect human health and God's creation by working towards comprehensive regulation of existing methane pollution.
