Dear Mr. President:

We, a widely-representative group of American Jewish leaders, are alarmed by your announcement on December 4th of your plans to reduce Bear Ears National Monument by 85% and cut the land protected by Grand Staircase-Escalante National Monument in half. We urge you to reconsider, and if not, we pledge to work with Congressional Leaders to restore protections to sacred sites, important artifacts, and critical habitat.

As defenders of religious liberty, we are concerned that the religious practices of Hopi, Navajo, Zuni and Ute tribes, who all hold the land in Bear Ears as sacred, as well as the voices of leaders from dozens of additional tribes, have been ignored. Given both the ancient and modern history of the Jewish people, we understand both the power of traditions holding a particular piece of land as sacred and the devastation a people may feel when that sacred trust has been violated.

We also hold dear our moral responsibility *l'dor vador*, to future generations. Beginning with Genesis 2, we have been called to be *Shomrei Adamah*, guardians of the earth. The rich cultural, historical paleontological, and biological heritage that has been protected since 1996 at Grand Staircase-Escalante and is now protected at Bear Ears, should belong to all of America, now and for generations to come. From the more than 100,000 archeological sites in Bear Ears to the pristine wilderness habitats it contains, this parcel of land is precious as it is and should not be given over to those who only seek to extract a short-term profit.

Lastly, we are greatly distressed at the precedent that is being set. With the slashing of protection to these precious lands, what is to stop your Administration or those to come from dismantling the many other sites that National Monuments now protect? Should Fort McHenry be sold to the highest bidder? What would be the cost to our American heritage and history were sites like the Harriet Tubman Underground Railroad National Monument or Ellis Island, through which so many of our ancestors arrived at this great nation, were lost?

Without the foresight of your predecessors to establish initial protections as National Monuments, Bryce, Zion and even the Grand Canyon would not have survived intact to become

such treasured National Parks. We pray that you will find such foresight yourself and reverse your decision, thus leaving a wonderful heritage for generations of Americans to come.
